

FAMILY PASS APPLICATION 2018
\$150.00 NON-REFUNDABLE under *any* circumstances
Family Pass for: (Up to 5 people)
Red Bank Municipal Swimming Pool

The following rules and regulations must be followed. **This form must be completed and signed by applicant / purchaser over 18 years of age.**

1. Acceptable form of identification is required when application is completed.
2. The family **pass must be presented upon each admission** along with one other form of positive identification (**NO EXCEPTIONS!!**). All pass holders and family members included on the application are required to sign a registry upon **each** entry.
3. This **family pass expires** at the end of the **2018** season.
4. This pass is good **ONLY** for members of the **immediate family residing within the applicant / purchaser's home**. Family members must be listed on application when completed. Any questions about what constitutes an "immediate family member" will be resolved by the director of the Red Bank Swimming Pool. The director's determination will be final.
5. **Five (5) complimentary guest passes** will be presented to the purchaser of the family pass. These passes are yours to do with as you please; however, **lost, misplaced or stolen passes will not be replaced**. **Additional parties who are unable to present a guest pass upon presentation to the swimming pool will be required to pay the regular admission fee upon entrance.**
6. This **pass is good only for regular pool hours** and is not valid for any unscheduled after hour's activities, such as swim lessons, parties, or swim meets. Swim lessons, parties, or special activities can be arranged with the pool director.
7. All pool rules **must** be followed. ***Breaking pool rules may result in revocation of this family pass without refund.***
8. While we will make every attempt to maintain a safe and pleasurable environment at the Red Bank Municipal Swimming Pool; the Red Bank Municipal Swimming Pool, The City of Red Bank, nor any pool or City employee, or the Red Bank Pool Advisory Committee, Inc. will be responsible for any injuries or losses which may occur.
9. The price of the family pass is **\$150.00** for **up to five (5) members of the immediate family residing in the purchaser's home**. **Each additional family member residing in the purchaser's home is \$15.00 per person (no exceptions)**. **This additional fee does not apply to friends, nor does it apply to family not residing in the purchaser's home.**

THIS ADDITIONAL FEE DOES NOT APPLY TO FRIENDS, NOR DOES IT APPLY TO FAMILY NOT RESIDING IN THE PURCHASER'S HOME.
